1. That I, _____, am participating in a travel program, in the form of a yoga and multi-activity adventure in India, offered by Mandy Grant during which, I will receive information and instruction about Yoga and related topics. I recognize that this may require some physical exertion, which may be strenuous and may cause physical injury, and I am fully aware of the risks involved.
2. I understand that it is my responsibility to consult with a physician prior to and regarding my participation in the Yoga program. I represent and warrant that I am physically fit and have no medical condition which would prevent full participation in the program or any other activities offered during the program, such as but not limited to hiking, paddling, swimming or any other activity that I may choose to experience.
3. In consideration of being permitted to participate in this program, I agree to assume full responsibility for any risks, injuries or damages, known or unknown, which I might incur as a result of participating in the program or any extramural activities whilst on the trip. This includes all activities and all road, train and air travel within India.
4. In further consideration of being permitted to participate in this program, I knowingly, voluntarily and expressly waive any claim I have against Mandy Grant or Juluka Yoga for any injury or damages that may be sustained as a result of participating in the program or simply being on the tour.
5. I recognize that this retreat and tour is being hosted in India and that I am to follow the laws of India.
6. I acknowledge that my deposit of \$600 is non-refundable and that I have been encouraged to obtain trip cancellation and interruption insurance, as well as medical insurance.
7. I acknowledge that the second payment of \$800 is due by April 1st, 2020
8. I acknowledge that full payment of the balance is due by August 10th, 2020.
9. I acknowledge that if I cancel before April 1st, 2020 all monies paid will be refunded, except for the non-refundable deposit of \$600. After April 1st, 2020 I will not be entitled to a refund and should seek compensation from an insurance company I may have secured.
10. I acknowledge that if any unforeseen circumstances arise that are not within the control of Mandy Grant for example but not limited to, a travel ban, an act of war, a weather event or other unlikely but possible event, I will not seek compensation from her, but instead look to my travel insurance company.
11. I, my heirs or legal representatives, forever release, waive, discharge and covenant negligence or other acts.

I confirm that I have read and understand all the terms set out in this document, including the refund policy; that I am 18 years of age; and that I am aware that this waiver and release is binding upon me, my heirs and personal representatives.
